(g) If Kids Helping Kids, a Pathway Family Center has determined that a serious medical; psychological, and/or social condition exist: that precludes further responsible treatment;

(h) For such other reasons, including but not limited to non-payment of fees, that Kids Helping Kids, a Pathway Family Center determines as being in the best interest of the Client and/or other Kids Helping Kids, a Pathway Family Center Client; engaged in the program at the time.

In the event the Client is terminated in accordance with the provisions of this paragraph, any part of the fee paid pursuant to this agreement to Kids Helping Kids, a Pathway Family Center will only be refunded in accordance with Kids Helping Kids, a Pathway Family Center's policy regarding refunds as set forth in the Rules.

# 5. Voluntary Withdrawal of Client from Program —

- (a) Voluntary withdrawal of a minor from the program shall be made through verbal consent given to the program nurse (4 times daily), established pursuant to the Program Rules. A private conference will be held between the program counselors and senior staff members of Kids Helping Kids, a Pathway Family Center and the Program Participant and/or Client. Such conference shall be held within a reasonable time period after notice of intent to withdraw has been given by the Client in order to give serious consideration to the desire to avoid impulses and/or transitory desires on part of the Client. In the event such minor Client shall proceed to full withdrawal from the kilds Helping Kids, a Pathway Family Center program, such Client shall only be released to the parents or legal quardians of such Client. In the event such parent or legal guardian refuses to accept the Client, such client shall be released to appropriate State agency.
- (b) Voluntary withdrawal of a Client who has reached his/her majority under State law shall give notice of his/her intention to so withdraw through the aforementioned process in Section A as described in the Rules. Such withdrawal procedures shall include a conference between the Client and a designated official of Kids Helping Kids, a Pathway Family Center, and should the Client, following such conference, still desire to withdraw, such withdrawal shall be accomplished within a reasonable and appropriate time following such conference. In the event such adult Client refuses to participate in Kids Helping Kids, a Pathway Family Center's normal termination procedure as outlined herein and as outlined in the Rules, such client shall be released from the program immediately.

In all events, the determination of a reasonable time and appropriateness of withdrawal procedures shall be governed by the laws of the State of Ohio. In the event the Program Participant and/or Client fails to comply with the above-described procedure with respect to voluntary withdrawal, Kids Helping Kids, a Pathway Family Center shall not be held responsible for any actions, causes of action or damages relating to or arising out of such withdrawal from the Kids Helping Kids, a Pathway Family Center program.

10. Financial Commitment – In consideration of the services to be rendered to Client by Kids Helping Kids, a Pathway Family Center, Program Participant and/or Client agrees to pay the following current fees and expenses for services rendered and to be rendered while Client is participating in the Kids Helping Kids, a Pathway Family Center program:

The total of the 1st and 15th day payments includes but is not limited to the following: Initial Assessment Fee, Admission Fee, Intake Laboratory Fee, Physical Examination, Psychiatric Evaluation, Psychological Examination, Nursing Assessment.

The amount due at admission is non-refundable 48 hours after the date of admission. If a withdrawal occurs prior to this time, this amount will be refunded, less fees actually incurred to the point of withdrawal.

Treatment fees are incurred according to Client's level:

	Standard Fees
Level I	\$325.00 per day (5 days per week)
Level II	\$325.00 per day (5 days per week)
Level III	\$325.00 per day (5 days per week)
Level IV	\$225,00 per day (4 days per week)
Level V	\$225.00 per day (4 days per week)

Program costs are approximately Sixty Six Thousand Dollars (\$66,000.00), however Program Participant may qualify for a discount on their self-pay, out-of-pocket portion of the fees according to the % Tiered Discount Sliding Scale based on adjusted gross income. If the Program Participant qualifies for a discount, their out-of-pocket treatment fees will be capped according to the scale. Any insurance reimbursement received will be applied to treatment fees above the capped self-pay portion of total fees up to a total of Sixty Six Thousand Dollars (\$66,000.00). Whatever insurance does not pay of the remaining amount over and above the capped self-pay portion, Kids Helping Kids, a Pathway Family Center will cover the balance through Teen Sobriety Sponsorships.

Additional fees will be assessed a rider the following conditions:

- (a) Additional Family Sessions Standard fees Include one individual family session twice a month. If multiple sessions are required due to divorce, the second session will be billed at a rate of \$165.00 per session. (See addendum)
- (b) Miscellaneous Exam: The admission fee covers one psychiatric evaluation, one psychological examination, and one physical exam. If additional exams or medical visits are necessary, they will be billed as the services are performed.
- (c) Additional fees \$50.00 per hour plus expenses will be charged for Kids Helping Kids, a Pathway Family Center staff to attend court or any other miscellaneous fees other than listed previously.

This is made possible through Kids Helping Kids, a Pathway Family Center Scholarship program.

Program Participant must bring in a copy of last year's tax return and a copy of two recent pay stubs subsequent to admission to verify their information within 15 days of admission. incurred are paid in full. Failure to make any payments by the due date stated on the bill will result in the imposition of a late charge of \$100.00. Administrative discharge of the Client from the program will be initiated if payment has not been received within two weeks of the due date. Upon notification of discharge, the clinical team has fifteen (15) days to devise an effective aftercare plan. A therapeutic discharge in no way releases Program Participant from paying for services rendered up to the date of discharge. If an account must be turned over to a collection agency for collection, a 35% administrative fee (of the outstanding balance) for collection services will be added to the account and interest will accrue at 18% of the outstanding balance.

11. Insurance Claims - Raimbursement from medical insurance cannot be guaranteed by Kids Helping Kids, a Pathway Family Center. Kids Helping Kids, a Pathway Family Center staff will provide to Program Participant and/or Client information and assistance to enable Program Participant and/or Client to prepare and process a claim in response to an insurance company's inquiries.

## 12. Client Property Policy --

- (a) These are any items brought by a Client to the Kids Helping Kids, a Pathway Family Center program, which are in the opinion of Kids: Helping Kids, a Pathway Family Center evidence of, or related to drug usage, or articles that in the opinion of Kids Helping Kids, a Pathway Family Center are related to or used in any criminal activity. Program Participant and/or Client agrees that such articles may be retained by Kids Helping Kids, a Pathway Family Center or may be released by Kids Helping Kids, a Pathway Family Center to appropriate law enforcement authorities as Kids Helping Kids, a Pathway Family Center shall in its sole and absolute discretion determine.
- (b) Any tie brought by a Client to the Kids Helping Kids, a Pathway Family Center program, which is in the opinion of Kids Helping Kids, a Pathway Family Center staff an "old tie", will be confiscated and not returned to the Kids Helping Kids, a Pathway Family Center Client. Articles of value (jewelry, vehicles, etc.) will be released to the Program Participant in the case of a minor Client to such responsible person as authorized by the adult Client.
- Parental Participation -- Kids Helping Kids, a Pathway Family Center is a family-oriented treatment program and as such parents or parent surrogates are required to participate in meetings and group sessions as well as other aspects of the program. An exception to full participation on the part of the parent or parent surrogate may be arranged by Kids Helping Kids, a Pathway Family Center on an individual basis taking into consideration the family circumstances.
- 14. Client Living Arrangem ents When client is housed outside of Program Participant's home, Kids Helping Kids, a Pathway Family Center vill reimburse the provider for \$5 per meal, up to \$15 per day per client when billed.
- Indemnification Kids Helping Kids, a Pathway Family Center undertakes with the consent of Program Participant and the parents and/or is gal guardians of the Kids Helping Kids, a Pathway Family Center Client, to treat the Client for his/her drug dependency problem in accordance with generally accepted clinical treatment standards. It is understood that under certain circumstances in an effort to prevent physical harm to Client or other, it may be necessary for Kids Helping Kids, a Pathway Family Center or its staff members and employees, to hold or otherwise use acceptable means of physical restraint. Program Participant and/or client agree that such methods

The Program Participant and/or Client do hereby indemnify and hold Kids Helping Kids, a Pathway Family Center, its directors, officers and employees, harmless for any and all liability, loss or damage as a result of claims, demands, costs, and/or judgments (including reasonable attorney's fees incurred in the defense of such claim or action) against it or them arising out of the care or treatment of Client by or on behalf of Kids Helping Kids, a Pathway Family Center or the damage so claimed is caused by or arises out of the sole, primary or concurring negligence of Kids Helping Kids, a Pathway Family Center or its directors, officers and employees.

- General Release Program Participant and/or Client who has attained their majority are fully aware that during the course of treatment, Client may accidentally cause himself/herself to be injured in the treatment program, such Client will be taken to receive medical attention promptly. In consideration of the services to be rendered by Kids Helping Kids, a Pathway Family Center, Program Participant and/or Client hereby releases Kids Helping Kids, a Pathway Family Center, its employees, officers and staff from any and all liability in connection with any occurrence that transpires during the course of treatment arising out of or relating to such treatment in the Kids Helping Kids, a Pathway Family Center program. It is further agreed to release, indemnify and hold Kids Helping Kids, a Pathway Family Center and any of its employees, harmless from any and all actions, causes of actions, liability and costs of every kind or nature including attorney's fees and court costs in connection with the treatment and supervision of the Client or other family, members.
- Program Participant and/or Client desires to withdraw from the Kids Helping Kids, a Pathway Family Center program against the advise of Kids Helping Kids, a Pathway Family Center or its staff or employees, Program Participant and/or Client hereby releases Kids Helping Kids, a Pathway Family Center its staff and employees jointly and individually, from any and all liability of any nature for any reason whatsoever including any injury or harm of any kind which may result directly or indirectly by reason of such withdrawal, and hereby waives all such rights of action which may now exist or later be obtained as a result of such withdrawal as well as any rights of action or claims which may have arisen while Client was a participant in the program. Program participant and/or Client understands the medical, psychological, and emotional complications and the possible results of such complications as a result of such withdrawal. This release is made with full knowledge of the danger that may result from withdrawal from the program.
- 18. **Arbitration In further consideration of the agreement to render services to Client, Kids Helping Kids, a Pathway Family Center and Program Participant and/or Client do hereby agree as follows:** 
  - (a) It is understood and agreed that all complaints, disputes, or grievances arising between Kids Helping Kids, a Pathway Family Center and the Program Participant and/or Client involving questions of the meaning, interpretation, or application of any clause of this agreement, or any breach or threatened breach of the agreement, or any acts, conduct or relations of whatever nature between Kids Helping Kids, a Pathway Family Center, its staff, employees, agents and volunteers and Program Participant and/or Client, may, if unadjusted, at the sole option of Kids Helping Kids, a Pathway Family Center, be referred to and submitted to arbitration before a panel of three arbitrators. Such arbitration panel shall be composed of an arbitrator selected by Kids Helping Kids, a Pathway Family Center, an arbitrator selected by the Program Participant and/or Client, and such two arbitrators shall select a third arbitrator. Such arbitration will be conducted in accordance with the

rules and regulations designated by the American Arbitration Association. The parties hereto acknowledge and agree that by agreeing to the arbitration as set forth in this agreement they waive their right to have such dispute initially decided in a court of law. The arbitration as provided under this paragraph shall be subject to the laws of the State of Ohio as they relate to judicial review of arbitration proceedings.

(b) This paragraph shall not limit Kids Helping Kids, a Pathway Family Center's rights under this agreement to exercise its professional judgment to refer Client to other drug rehabilitation programs or to decline further treatment of Client.

BY SIGNING THIS AGREEMENT, YOU ARE AGREEING TO HAVE ANY ISSUE DECIDED BY NEUTRAL ARBITRATION AND YOU ARE GIVING UP YOUR RIGHTS TO HAVE SUCH ISSUES DECIDED BY A COURT OF LAW.

- Booster Club The parents of Klds Helping Kids, a Pathway Family Center Clients have or may organize a booster club to promote the awareness of the program in the community and to raise funds necessary to assist Kids Helping Kids, a Pathway Family Center to continue as a privately funded program. Such booster club may also assist Kids Helping Kids, a Pathway Family Center in certain helpful operations of the program including, but not limited to answering the telephone, manning concession stands at parent meetings, manning parking lots, and serving at such other events as shall be needed from time to time.
- 20. Governing Law This agreement shall be governed by and construed in accordance with the State of Ohlo.

- 24. Severability The invalidity of any provision of this agreement as determined by a court of common jurisdiction shall in no way affect the validity of any other provision hereof.
- 25. Entire Agreement This agreement and all of the documents as referenced herein including the Rules and Regulations and financial schedule, constitute the entire agreement of the parties hereto pertaining to the subject matter and supersede all negotiations, preliminary agreements and all other prior and contemporaneous discussions and understandings of the parties in connection with the subject matter of this agreement. Except as provided herein, no covariant, representation or condition not expressed in this agreement or in an amendment hereto made and executed in accordance with this agreement, shall be binding upon the parties hereto or shall effect or be effective to in terpret, change or restrict the provisions of this agreement.

# TEMPORARY HOST HOME AGREEMENT

I agree to provide a host home for Kids Helping Kids, a Pathway Family Center, clients other than my own child. I understand assignments will be made for clinical and security reasons at the discretion of staff.

I agree to provide properly situated smoke alarms and fire extinguishers and to secure my home with alarms. I agree to have all alcohol and non-prescription and prescription drugs locked up, as well as knives and any other things that staff would view as a potential weapon or harmful substance if swallowed.

I agree to provide and have approved a fire escape and disaster plan for my host home. I agree to review the approved plan with my host household monthly, and review with any new clients I have in my host home. I also agree and understand that my host home might be subjected to a re-inspection by the staff at Kids Helping Kids, a Pathway Family Center.

I agree to provide sleeping accommodations, sanitary conditions and nutritious breakfasts and snacks and other meals missed at the program. Also important, I agree to provide an emotionally warm environment for my host children as other families did for my child.

I understand that in case of an e-mergency, I may use physical restraint or seclusion on a client only if absolutely necessary to protect the clients from running away or injuring themselves or others. I understand that I shall not use physical restraint or seclusion as a punishment, for the convenience of the host home or as a substitute for activities. When such an incident occurs I will notify the program as soon as possible using the emergency pager numbers provided to us. The Kids Helping Kids, a Pathway Family Center staff will investigate all incidents.

I further agree to discuss only with the staff at Kids Helping Kids, a Pathway Family Center the behavior of the children or their issues while in my home.

I also agree to provide safe and timely transportation for my host home to and from the program.
