TIPS ON LETTER WRITING

- 1. Keep the letter SHORT, rarely more than one page. Type if you can, or write legibly.
- 2. Write it in YOUR OWN WORDS and include your own thoughts.
- 3. Show your familiarity with the subject (carefully study the summary of recommendations of the task force on drunk driving and the statistics). This will indicate that you are serious about the issue, unlike the casual, uninformed correspondents who produce the business of constituent mail.
- 4. BE SPECIFIC about what you want your legislator to do, i.e. suggest that he propose legislation that you feel particularly strong about, and that he support all of the recommendations of the task force.
- 5. Give reasons for your position BRIEFLY. Cite your own sperience and observation, i.e. if you know of someone who was killed or injured by a drunk driver, relate that fact briefly or state your concern for the safety of your loved ones on our highways.
- 5. Ask your legislator a DIRECT QUESTION about his position on this subject.
 You want to receive a clear answer, not a form letter. Ask for a reply.
- 7. You need not mention your membership in MADD or any other organization. The individual citizen's letter is what counts.
- Be courteous. DO NOT THREATEN. You can best show your genuine concern by providing information on the subject, such as statistics.
- Address letters to your legislator at his home address (see attached list).

 WHEN THE LEGISLATURE IS IN SESSION (mid-JANUARY to mid-MARCH 1984) address
 letters to all legislators to: Honorable (name), General Assembly Bldg.

 910 Capitol St., Richmond, VA 23219. Richmond phone numbers of legislators will be provided at a later date (when the legislature is in session).
- 10. Finally, remember -- ANY LETTER is BETTER THAN NO LETTER!! Post cards are second-best. It's hard to get enough information on them. You may also write a letter and have others co-sign with you (including their addresses).

OR you may prefer to phore your legislator. Do not hesitate to do so. Organize your thoughts; be brief; ask a direct question; convey the same message as you would in a letter; get a clear reply.

Dear Mrs. Reagan:

I am a mother whose daughter graduated from Straight, Inc., and she is presently employed as part of their Senior Staff.

I am concerned about the law that states no one can be held against their will unless they pose a serious threat to themselves or others. Because of this, a parent does not have the right to commit a child to treatment if the child does not submit voluntarily. Even then, whenever the child chooses to leave treatment he has the "right" to do so.

Considering this, I find it important to redefine the term "serious threat to himself". Since chemical dependancy is chronic, progressive and TERMINAL, it seems to me the disease provides the behavior of the child being a "serious threat to himself". Suicide attempts are a common side effect on this self-destructive path of life.

Another serious problem for parents who wish to take steps toward treatment for a child is that the insurance companies are writing coverages excluding treatment for chemical dependancy except for a 28-day program, which in the case of childre is sadly ineffective. Long-term is vitally important to get our children through the confusion of adolescence.

Both of theseissues are perpetuating "the problem". I am in hopes that you can reply as to what direction could prove fruitful in each of these issues so that concerned parents are able to:

1. Afford the necessary treatment for their child's wellness.

2. Commit the child to long-term treatment with confidence that he <u>must</u> stay until treatment is complete.

Dear Judge

I received your reply yesterday to the information I sent you on Straight, Inc.

You inquired about the costs for housing the children at the hostfamilies homes. Currently, this is \$150/month and is payable to Straight, Inc. because a child does not stay for any length of time with the same family, perhaps 10 days at each home on First Phase. I reason that this is sound judgment in that the child won't become overly attached to one family, displacing his/her own. Also, the child gets "Aunts and Uncles" all over town who are all in the program and all consistent with rules/affection. The homes all have to be "safe"--not in the sense that they have bars on the windows/doors, but they do have a heat-sensor on the doors that will sound an alarm if the doors are opened at the wrong time. These families transport the child to the Straight building every day and bring them back every night, with no stops enroute. There are no phone calls, no letters allowed -- the child's anonymity is protected at all times. On First Phase, on" to at all times, by the back of her pants by a child who is on a higher Phase. Even so, sometimes they run away. Close co-operation between the local Swat Teams/parents/Straight staffers abound in such situations. Children who have been in the program 3-4 months usually come back of their own accord, testifying to the positive feelings they have experienced in being a part of the Straight community.

Being a First Phaser, is experiencing a great deal of pain right now. I am very glad because unless she is miserable being a "druggie" she will have no motivation to change. The open confession she is subjected to daily has started to take effect since she went in Nov. 12. I tried to get her to go to confession to Fr. Leonard while we were maintaining her at home--she went once and has a "neat discussion" instead of penance and confession and reconciliation. (Not enough pain yet.) She is progressing nicely so far because she has earned the right to talk with us for 5 minutes the past 2 visits we have made there. She has shed light on several incidents where she had blatantly lied--one being in Court.

I know of one child who is in the program under Court Committment, so it is being done.

Besides the \$150/month out-of-pocket expense, there is also a \$57/month charge for her supper, which she has each night at the Straight building. These, of course, are not covered by insurance. We are severely restricted as to what we may appropriately give her for Christmas. Each child may have 1 present to open. It may be 1 complete clothing outfit--no cards. Until reaches Second Phase, she is not allowed to listen to music, watch TV or read. On Second Phase, the reading restriction is lifted only to the extent that she is allowed (and must) read the Bible with her Second Phasers and her host family. On Third Phase she will re-enter public school, but will be directly transported back to the Straight building until 9:00 pm each school day.


As you see, it is highly structured with daily group confession, group confrontation, posttive peer culture, in a strong adult community of loving, extended family settings. There are many integrated activities-picnics, money-raising ventures, just plain old-fashioned fum. This community is counter-culture to the standards of 1984 and I am thrilled to be a part of it. This needs to be extended to every city and every state in our country in order to significantly diminish the demand for drug use, as well as the efforts to eradicate the supply.

I hope you can have some impact on funneling our children into this program with its 85% success rate, instead of advising parents to put them into the 28-day "wonder" programs at P.I.R./Westbrook/etc. We have been advised that it takes at least all of the 28 days to get a child to realize fully that their "stinkin thinkin" is directly related to use of drugs.

I will be most happy to provide you with any information that will help educate our local professionals who are not familiar with this program.

It brought back to me the pain of having a 13 year old daughter who listened to this type of message and became psychologically addicted to marijuana and alcohol, then LSD. It has been 5 long years of exhausting our emotional and financial reserves to turn her around, but we DID TURN HER AROUND and are proud of her today.

You can expect a LOT OF HEAT in 1986 from the parents of the Greater Richmond area if you continue to be slack about drug-use by playing suggestive/implicit music. WE ARE ORGANIZED, AND WE ARE SICK & TIRED OF MEDIA MESSAGES PROMOTING SELF-MEDICATION.

Paying insurance premiums to cover treatments of \$10,000/month at Westbrook \$20,000/month at Psychiatric Institute of Richmond, Colonial in Petersburg, etc. are exhorbitant enough for parents. The insurance industry is getting fed up, also. And, yes, we have parents in the federation who are on the board at Blue Cross.

And as you can tell, I AM MAD!
