At its "Grand Gala" April 12, the Palm Beach International Film Festival will honor Robert Wise for lifetime achievement, an award as important to the giver as the receiver.

Wise, who directed West Side Story and The Sound of Music, has a mantel filled with Oscars and lifetime achievement awards from longstanding groups of much greater stature. But his presence gives this fledgling festival status.

At last year's inaugural, Van Johnson, Donald O'Connor and Cyd Charisse saluted Gene Kelly, who had died in February. Wise is expected to attract more top-notch talent. Festival operations director Susan Fraine expects to announce several in early February.

"There are 250 festivals in the United States," Fraine said. "This is the only one I know of where the proceeds go back into the arts community. It's because of that commitment that we are attracting people like Wise."

The deadline is up, and the Diet Dr Pepper National Pro-Am is at its LPGA limit. And it's dangerously close to the weight limit on celebrities.

Not only was Tuesday the final day for changes to the list of 96 LPGA players in next week's event at Ibis, but tournament officials also reeled in four late celebrity catches. And with apologies to tennis star Gigi Fernandez, these are big ones that didn't get away.

Now on the first tee, he's a former Outland Trophy winner out of Nebraska now with the St. Louis Rams, weighing in at 6-foot-5, 305 pounds, Zach Wiegert.

Rounding out, and we do mean rounding out, the foursome is Tampa Bay Buccaneers nose guard and former Florida standout Brad Culpepper (6-1, 275) and ex-Redskins linebacker Greg Manusky (6-1, 242).

"If and when they are out of the tournament, they may double as the biggest marshals we'll ever have," joked tournament director Tom Clark.

Actually, Wiegert plays to a 10-handicap, and Culpepper has hosted a charity golf tournament for three years to benefit the Children's Miracle Network.

Fernandez, a 20-handicap, will team with Jane Geddes.

Clark said the celebrity field could grow from nine to 12 by week's end. Steve Nicklaus, chief operating officer for Executive Sports, will play as a celebrity and is expected to unveil two names.

The field now has 32 of last year's top 50 moneywinners - with the additions of Juli Inkster (21st) and Tracy Hanson (37th) - and 19 of the top 30 career leaders. There are also three Hall-of-Famers in JoAnne Carner, Betsy King and Pat Bradley.

Benjamin star newest Buckeye: Benjamin senior Tatiana Belham was in a no-lose situation. She could follow in dad's footsteps and accept a golf scholarship to UCLA. Or she could shoot for one of the finest educations in the country at Stanford.

So Belham chose Door No. 3, and signed a letter-of-intent to play golf at Ohio State.

"She told me, `If someone was going to screw up my swing at UCLA or Stanford, I don't want to go,' " said her father George. "She said, `I want someone who works with (instructor) Mike Adams.' "

Coach Therese Hession and her Buckeyes make frequent visits to Adams at the Academy of Golf at PGA National, and Tatiana called that a swing in her decision.

"I've been with Mike almost three years," said Tatiana, arguably one of the state's top girls and an amateur to watch in next week's Diet Dr Pepper National Pro-Am. "When I got to Mike, I was a 15-handicap. Now, I'm a 5."

Tatiana received news last week that a wealthy Naples woman, who wanted to start helping Florida golfers interested in going to Ohio State, is adding to Belham's partial scholarship.

Pros get jump at Par-3: Fans can get a coming attraction of next week with Saturday's 14th annual Palm Beach Par-3 Pro-Am Benefit. Singer Island's Michelle McGann will defend her title in a full field of 23 teams made up of one LPGA player and four amateurs. There is a shotgun start at noon, and the \$10 admission includes a raffle ticket.

Other LPGA stars include Judy Dickinson (whose '95 team set the tournament record), Sally Little and Carner.

And don't forget Atlantis: And for those who can't get enough of this celebrity thing, there is the Growing Together, Inc. 12th annual Pro-Am Celebrity Golf Classic Monday at Atlantis Country Club. Among the names for the 1 p.m. start are Dolphins quarterback Craig Erickson and ex-Yankee great Whitey Ford.

Somehow McGann has found time to be honorary co-chair with Erickson. Aside from playing in three pro-ams in over a week, McGann will speak at functions the next two Tuesdays. She will be at Tuesday's Chamber of Commerce breakfast at 7:45 a.m. in the Sheraton

West Palm Beach.

Ryan Howison already had enough scrapbook material to save for his grandchildren. But he's writing sequels.

Howison's glory days began as a baseball star for Atlantic High in the mid-1980's, and continued at North Carolina, where he started at third base for the Tar Heels' 1989 College World Series' team.

Seven years later, Howison has reached another pinnacle - in golf. Sunday, the West Palm Beach resident won the Nike Tour's season debut tournament in Lakeland.

"I decided after my senior year in college to give golf a try," said Howison, 30, who lives at Bear Lakes but plays out of Addison Reserve in Delray Beach. "I played in the summers all I could, and maybe once during the school year. I'd go from about an 85 to start the summer to about par or 75 at the end.

"It was just enough to make me think, `What if I did this full time?' I also wanted to avoid the `what-ifs.' "

That was was in 1990. By '95, Howison actually had his PGA Tour card. The card slipped through his fingers by season's end, as Howison did no better than a 38th-place finish.

And to use a baseball analogy, 1996 for Howison was like being demoted from the major leagues and trying to play out the season in Class AAA.

"Last year, I just didn't have a very good attitude," said Howison, whose '96 highlight was a couple of top-10 finishes. "I had gone from the major leagues, was demoted and was not happy to be there. But it was no one's fault but mine.

"Now, anyone and everyone you talk to will tell you I'm excited to be there."

Howison actually had a dark cloud to ruin his silver lining, but he wouldn't let it.

In December's qualifying school, Howison was three shots off the pace going into the final round. But after Howison opened with two birdies, a "monsoon" canceled the final round and his chances at a PGA Tour card.

But talk about making the most of a situation. Howison opened the Nike Tour season with rounds of 66-65-69-69 for a three-shot victory and \$36,000 - more, he said, than he's made in one season on a tour.

"It means more to me mentally than financially," he said. "If I was 10th at Pebble Beach last week, I would have made \$17,000 more than I did. But it means more to me to win the Nike event. I wanted to prove something to myself."

Coody wins Murphy's Pro-Am: Charles Coody might be one person in the working world who likes Mondays. Coody, fresh off a disappointing six-over 77 Sunday and 46th-place finish at the Royal Caribbean Classic, rebounded with a first-place 65 in the Delray Dunes/Bethesda Memorial Hospital Pro-Am Monday.

Boynton Beach's Bob Murphy, the senior tour star who heads up the tournament, was just one of 31 seniors helping to raise over \$100,000 for the second year in a row.

Lee Trevino, who has played in all but two of the pro-ams since its inception in 1969, tied Jim Albus, John Bland and Dick Hendrickson with a 67 for second low pro. J.C. Snead's group of Jacques Bonneau, Jon Gale, Mike O'Grady and Dave Smith won low team with a 51.

Atlantis pro-am sets record: Monday's 12th annual Growing Together Inc. Celebrity Pro-Am drew a record 150 golfers, including 20 celebrities, to Atlantis Country Club. Students meet at police seminar

JUPITER - If a Jupiter Middle School student wanted to find alcohol or marijuana during the day, would it be difficult to find any on campus?

When the question was posed last Wednesday to a group of middle school students, more than half replied that such items are easily available daily. As for hard drugs - heroin, cocaine and LSD - only a few students said they could, if need be, get their hands on them. Still they said, those drugs are on campus.

When questioned about drugs, using the street names for different narcotics, most of the kids laughed without comprehension, until the formal name of the drug was mentioned.

"You guys know more than I do about it," one eighth grade boy stated. But then he added, "we just do it."

As for gangs, one girl objected to a reference that she was in such a group. She said that the 16 people she hung out with in and out of school, beating up other kids and cursing teachers, is a "clique."

"If you're beating people up, you're in a gang," replied Jupiter Police Officer Dominick Barbanera, who is the town's liaison to the Palm Beach County gang task force.

The comments from the kids and Barbanera came during the second of a three-part series being put on by the middle school, Communities in Schools and the Jupiter Police, called the Family Awareness Seminar and Training (FAST). The session last Wednesday was just for kids. About 15 teenagers attended; several had been given the option to attend or face suspension.

The final session, to include both kids and parents, is set for this Wednesday, Feb. 19.

Last week, the kids in attendance were questioned about their attitudes on domestic violence, drugs and gangs, and got to meet with three of their peers - ages 14, 16 and 18 - who are now participating in a drug rehabilitation program.

"Most kids in rehab are not there voluntarily," said Janet Pezelj of Growing Together, a rehabilitation program in Lake Worth.

The purpose of the FAST session is to alert teenagers about the consequences of their actions.

"We find that kids who join gangs are mostly looking for attention. They are bored at home and are looking to hang out with kids who are considered exciting," Barbanera said.

He recalled Daniel Elliot Hobart, a former classmate of many of the teenagers, who was killed, along with Zachary Amsden, 15, on May 26, 1996, when the car they had taken from Hobart's mother slammed into a home in North Carolina, ending a 30-mile police chase at speeds up to 100 mph. Brianna Laszczak, 17, of Jupiter, who was driving the car, is awaiting trial on two counts of involuntary manslaughter.

"Danny used to hang out with Fuss (a local gang recruiter)," Barbanera said. "Fuss brainwashed him and, in the end, (Hobart) went through a windshield."

The most instant impact on the kids came from a video on the effects of smoking. The video of a Jacksonville TV news report highlighted people with cancer of the larynx, liver and mouth, who have holes in their throats and spend hours hacking up phlegm - and, in one case, a man with half his face rotted away from years of smoking.

The boy who commented on the names of drugs said he would now think about giving up smoking, but one girl doubted she would because smoking is part of her identity.

"I know my friends wouldn't want me around any more if I didn't smoke," she said. "I left my true friends so I could get in with them (my current friends)."

BENJAMIN STUDENTS BUILD ROBOT

What started as an idea just a few months ago took shape in a teacher's backyard and recently represented The Benjamin School in a national competition.

The Indestructible Bucs, a robot built by students and sponsored by Pratt & Whitney, came in the top third of the 151 competitors from around the country at the recent U.S. FIRST (For Inspiration and Recognition of Science and Technology) contest at Walt Disney World's EPCOT Center, said teacher Bill Fitch, who worked with the students.

Team members came up with the idea, designed and built it within six weeks in the backyard of teacher Anita Buxe and her husband, Paul Buxe, a Pratt & Whitney engineer.

Under the rules, the robot had to to lift up inner tubes and place them on a goal in a tic-tac-toe pattern, if possible, while fending off other robots. Fitch said.

"The competition was heated," Fitch said, adding that it was taped by ESPN and to be aired at a later unspecified date.

Students who worked on the robot included Adam Ackerman, Rena Borucki, Ken Click, Beth Fennell, Tod Kawecki, Jeff Petrone, Mariah Ripma, Katharine Riso, Mark Riso, Chris Seaton, David Shapiro, Michael Shapiro, Chris Timchak, JimVanek, Amanda Peroulaikis, and others who did not go on the trip.

Engineer Robert Rowe got the project started, Fitch said. Other Pratt engineers who helped were Greg Andries, Matt Hafner, Ed Kawecki, Bruce Lyon, Sue Skemp, Bud Smith and Bill Speers.

"It's good for the community and it's good business," said Jack Scarola, a partner in the firm who lives in Jupiter.

PALM BEACH GARDENS - Attorneys who are hired by the firm of Searcy Denney Scarola Barnhardt & Shipley must agree to donate some of their time to the community.

In addition to providing pro bono legal services, the firm also has paid for time on TV and radio, so drug- and alcohol-prevention groups can get out their word. The commercials are recognizable for the "time to care" catch line.

"It's good for the community and it's good business," said Jack Scarola, a partner in the firm who lives in Jupiter.

Scarola noted that friends and acquaintances have been affected by the destructive nature of substance abuse, and now, with his own kids starting to have children, he hopes they can grow up in a more drug-free society.

Last Thursday, Scarola and eight other Palm Beach County residents were recognized for their efforts to prevent and treat substance abuse by The Partnership for a Drug-Free Community, during its Red Ribbon Celebration at the Palm Beach Gardens Marriott.

The Partnership is an umbrella group for all the organizations in the county that work to prevent and treat people with substance problems. The Red Ribbon Campaign was started in 1985 as a response to the torture and murder of Federal Drug Enforcement Administration Agent Enrique Camarena by drug traffickers in Mexico, said Matt Bradley, a Boynton Beach City Commissioner, who is a co-chairman of the campaign.

"This is one of the things we do," Bradley said. "We also work in partnership with drug prevention programs at the schools."

Scarola said he was honored, but the Red Ribbon business award should go to his entire firm for its work.

Jupiter Farms resident Mickey Bowman, executive director of Growing Together in Lake Worth, who received the service provider award, said it will take a community effort for drug use and abuse to decrease. Also, she said that programs such as the Red Ribbon Campaign will help change people's attitudes toward a more drug-free community.

"I think we can't stop the supply of drugs, but we can slow the demand," she said.

Others honored by the Red Ribbon Campaign included:

Robert Tatum, who organized the Citizens Observer Patrol in the Kennedy Estates and Limestone Creek, which has helped in the decline of criminal activity in the two areas west of Jupiter.

Dianne Hermanski, the club sponsor, for the "Just Say No" Club at Jupiter Farms Elementary School, which holds an annual hourlong event where about 840 students renew their commitment to keep the school and community drug-free.

Patricia Humm, the sponsor of the Jupiter Elementary School "Just Say No to Drugs" Club.

Su Jackson of WPBF-TV25 in Palm Beach Gardens, for her series of news stories about substance abuse in the county.

Palm Beach County School Board Police Officer John Pruitt, who works with pre-kindergarten through fifth graders at Washington Elementary School, and started the "Junior Police Akidemy," which is now used at 10 county schools and has drawn national interest.

The first thing Jaye Norris of Jupiter did after learning that she was one of eight finalists in the Newman's Own/Good Housekeeping magazine recipe contest was try to think up what she'd say if she won. She settled on: "If you get a call from Newman's Own, you must be doing something right."

As a finalist, Norris and a guest _ her son, Geoffrey, 7 _ were flown to New York City on Oct. 27, put up at the Waldorf Astoria hotel for five nights, received \$1,000 spending money, and were guests at a gala luncheon at the Pegasus Suite of the famed Rainbow Room, where Paul Newman himself tasted each dish and determined the winner. All of the entries, more than 5,000 this year, had to include a Newman's Own product (salad dressing, spaghetti sauce, salsa, popcorn or lemonade)

Even at age 72, Newman is still a heartthrob. As it turned out, his wife, Joanne Woodward, came along to help with the judging. This was a first since the contest began seven years ago. To date, \$1.3 million has been given to charities chosen by the winners.

This is in keeping with what Newman does with all profits, after taxes, from the sale of Newman's Own products. In the 15 years since he started the food company, he has given away \$90 million for charitable and educational purposes.

"This competition is a way to let other people give away my money," said Newman, smiling. One of the finalists from Massachusetts described it as a chance to be a "temporarily rich philanthropist."

This year's competition meant that another \$400,000 would be given to the charities selected by each of the finalists (\$50,000 on behalf of the grand winner and \$10,000 for each of the remaining finalists).

Norris entered her Steamed Clams With Pancetta in (Newman's Own) Diavolo Sauce. The recipe was inspired by the summers she spent as a child clamming in the Delaware Bay in Pennsylvania. But, she admits, you can replace the clams with shrimp, calamari or even lobster.

During the competition, her son was her biggest supporter. "I know my mom is going to win," Geoffrey told anyone who asked. "She's a really good cook, and I love to eat what she cooks."

About her own mother, Norris says, "She taught me a love of the kitchen." But it's only during the past three years that Norris began entering cooking contests. To date, she has submitted recipes to about 20. Her bacon-lettuce-and-tomato pizza put her into the semifinals in a recent Mama Mary's pizza crust competition, but this was the first time she's been a finalist.

The finalists' dishes were prepared for the judging luncheon by Waldy Malouf, executive chef and director of The Rainbow Room. Then they were lined up on the head table awaiting judging.

There was the Hustler's Catch submitted by Toshiko Lyons of Toledo, Ohio; Chocolate-Kist Peanut Caramel Bars from Elsie Wigdah of Ruthven, Iowa; Finger Lickin' Hombre Country Ribs from Doreen Velmer of Attleboro, Mass.; Franklin County, Florida's own Frankly Fantastic Seafood Gumbo provided by Jackie Gay of Carrabelle (close to the Georgia border); Zona Rosa Chiliquiles created by Crescent Dragonwagon (she insists it's her real name) of Eureka Springs, Ark.; Paulenta Pizza Faces entered by Sheila Devore Costello of Belmont, Calif.; and the Towering Inferno Creole Posole developed by Alexandra Sanchez of Albuquerque, N.M.

After Woodward and Newman sampled each, "oohing" and "aahing" convincingly, they left the table to confer, but not before Woodward announced: "I know which one I like best, and I know which one he likes best, and they are not the same."

She was right.

As far as she was concerned, the winner was the seafood gumbo (she had grown up on it in Thomasville, Ga., on the Florida border). "It brought back such wonderful childhood memories," she said later. "I knew right away that I had to pick it over all the others."

Newman picked the Towering Inferno. ("He's a sucker for black beans," Woodward explained.) Neither would give in to the other's choice. So, they reached a compromise.

They gave two grand prizes of \$50,000 each. Just another example of the Newman company motto: "Shameless exploitation in pursuit of

the common good."

As for Norris, who came home with \$10,000 to contribute to charity: She's on the cookbook committee of the Junior League of the Palm Beaches, so she committed half her winnings to the Junior League, specifically for its work with Growing Together, a drug and alcohol rehabilitation program for teen-agers in Lake Worth. The other half of the money she gave to the Marine Life Center of Juno Beach for their work with sea turtles. Her father taught her a love of the ocean, she says.

In a medium nonreactive skillet or Dutch oven over high heat, cook the sausage about 7 minutes or until browned. Remove from skillet and drain on paper towels. Discard all but 1 tablespoon fat from pan. Add scallions and cook over medium-low heat 1 minute. Stir in garlic and red pepper flakes. Cook 1 minute. Add sausage, pancetta, diavolo sauce, wine and bay leaf. Simmer, uncovered, 20 to 25 minutes. Arrange clams in sauce, cover and cook over low heat 10 minutes or until clams open (discard any that don't open). Serve immediately. Makes 6 servings.
